- Older Americans Act Title III
- Provides funding to enable local agencies to provide services for eligible seniors
- Eligibility includes people 60+ who do not receive ADvantage services
- Eligibility for Grandparents raising Grandchildren is 55+
- An assessment is required before services are provided

Possible services include:

- Meals Nutrition Counseling, Congregate meals,
 Home Delivered Meals, Nutrition Education
- Transportation Medical, Personal, and Caregiver rides
- In Home Services Minor Home Repair
- Caregiver Respite vouchers for caregivers and Grandparents raising grandchildren
- Other services Legal Assistance, Information Assistance and Coordination

The Oklahoma Family Network connects families who have children with special health care needs, disabilities or behavioral health concerns to other families, services and supports in their community.

Tribal Opioid Response is two part in nature.

- One being to provide <u>case management</u> services to any member, age 18 or older, of a federally recognized tribe having had a history of opioid misuse.
 - Those services include meeting the party where they are and providing resources to assist with recovery. Some examples include locating meetings, rehabilitation centers, and sober living options.
 - There is a focus on those involved with the Choctaw Nation recovery centers and court; case managers meet in these facilities monthly.
 - For qualifying members, there is a potential to be waitlisted for opportunity to be aided with sober living rental assistance in the amount of \$500 the first month and \$400 a month thereafter.
- The second area of focus includes community efforts and prevention.
 - In efforts to promote safe keep and disposal of medication, lockboxes and Deterra (drug deactivating charcoal) bags are available to those in need.
 - Puncture and fentanyl resistant gloves are available to law enforcement.
 - Opioid 101 trainings are available to both adults and juveniles.
 - Naloxone training and disbursement available to the public. **Please note any party with an open chart through the Choctaw Nation is eligible for a free Naloxone kit from any CNHSA pharmacy.
 - Mock bedroom set up also available to the public; this includes allowing individuals to enter into a room and discover what is the most current method of concealing drug paraphernalia.
 - Hosts annual conference, Navigating Mental Health and Substance Abuse through Counseling, Law Enforcement, and Judicial Process, which is set to occur August 25th-26th.

- Sibshops are fun, evidence-based workshops for brothers and sisters of children with special health care needs. The sibs are 5-15 years old.
- Sibshops provide peer support and sharing with other sibs along with fun and lively recreational activities. We promote friendship building, listening skills as well as a safe environment to talk about issues they might be dealing with.
- Sibshops are often held in conjunction with a respite program allowing parents to have a break for 3-4 hours on a Friday night or Saturday morning.
- Sibshops are a worldwide program and over 35 years old. Facilitators/Coordinators are volunteers and can be trained by Sooner SUCCESS staff. Donations of craft supplies, activity materials, and snacks are always appreciated.
- A few locations to note: Tulsa, Norman, Tinker AFB, Bethany/ North OKC, Mustang, Guthrie, Poteau, The Children's Center, and South OKC.

Lifespan Respite Grant Voucher Program

Eligibility for caregiver:

- Is 18 or older, full-time, unpaid
- Is a grandparent or other relative age 54 or younger raising a child
- No more than \$90,000 of annual household income
- Does not receive respite services or payments from other programs including, but not limited to foster care, Family Support Assistance Payment, OAA Title III-E, ODMHSAS Systems of Care funding, or a DHS Child Care Subsidy.

If the Care Receiver is an Oklahoma resident

Age birth to 59 who needs help with activities of daily living (ADL) who has

- Cognitive Impairment/Dementia
- Intellectual Disabilities
- Developmental Disabilities
- Mental Health/Behavioral Issues
- Physical Disabilities
- Traumatic Brain Injury
- · Other special health care needs

Does not qualify for respite services or payments through any other program including, but not limited to, DHS Developmental Disability Services, SSI-DCP, OAA Title III-E, ADvantage waiver program, Medicare-funded home health services or hospice.

Educational Vouchers

Educational vouchers help caregivers pay for care of their loved ones so they can attend training that assists with their caregiving.

- \$50 for half day training or \$100 for a full day training event per eligible caregiver.
- Must complete an application prior to the educational event
- Must be registered for the educational event

Emergency Vouchers

Emergency voucher is a one time, \$250, voucher issued on a case-by-case basis for full-time, unpaid caregivers that have an unexpected need for support in caring for their loved one due to surgery or unexpected hospitalization, death in the family or any other unexplained situation

COVID-19 adjustments through June 30, 2020

- Increase the current voucher amount from \$300 to \$400 every 90 days;
- Care providers must be age 18 or older and have a social security number and card plus the care provider can live with the caregiver and care receiver; and
- Lift the household income restriction of \$90K to no household income.

ADvantage Waiver eligibility requirements

To be eligible for the ADvantage waiver program, a person must:

- Must qualify financially for SoonerCare
- Be 65 years of age or over, or 21-64 and disabled
- Be determined to meet the Nursing Facility institutional level of care by nursing staff of Aging Services Division.
- Not have a primary diagnosis of developmental disabilities.
- Be a legal resident of the state of Oklahoma.


